

## **“365 Days of Starbucks Reserve Coffee” Sweepstakes**

### COMPLETE OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY

**1. How to Enter:** The Daily **“365 Days of Starbucks Reserve Coffee” Sweepstakes** (the “Sweepstakes”) begins at 6:00 PM (Eastern Time (“EST”)) on **August 13, 2013** and ends at 12:00 a.m. EST on **September 13, 2013** (the “Sweepstakes Period”). To Enter: Submit your favorite coffee pairing during the Sweepstakes period and submit the requested information, including the name of the food product(s) that make up the perfect coffee pairing to be automatically entered. You may only enter the contest once. You are eligible to enter one (1) entry, per person over the course of the sweepstakes. Online Entries must be received by 11:59:59 p.m. EST on **September 13, 2013**. The Daily Meal.com, Inc. (“Sponsor”) will not verify receipt of entries. All entries submitted become the sole property of the Sponsor and will not be acknowledged or returned. The Sweepstakes is governed by TheDailyMeal.com’s privacy policy, which is available on the Web Site.

**2. Eligibility:** To enter the Sweepstakes you must be a lawful permanent resident of the 50 United States or the District of Columbia and be 21 years of age or older as of **August 13, 2013**. Sweepstakes is void outside of the 50 United States (and the District of Columbia), in Puerto Rico, U.S. territories, possessions and commonwealths, and where restricted or prohibited by law. The Sweepstakes, and any web site pages and advertisements relating thereto, is intended for viewing only within the United States. You are not authorized to participate in the Sweepstakes if you are not located within the United States. **4. Prizes:** Total of fifty-one (51) prizes- One (1) Grand Prize: one half pound bag (approx. 14 total bags) of new Reserve coffees to be released from Sept 2013-Sept 2014. Reserve coffees will be released over the next year, but on average Starbucks has released about 14 a year; retail value \$200.00. Fifty (50) First Prizes: 50 \$5 Starbucks gift cards; retail value \$5.00. Total ARV of all 51 prizes being awarded is \$450.00 Sponsor reserves the right to substitute a prize of equal or greater value if the Grand Prize cannot be awarded as described for any reason. Taxes, gratuities and other expenses not specifically identified in these Official Rules are the sole responsibility of the Grand Prize Winner. No transfer or substitution for the prize allowed except at Sponsor's sole discretion

**5. Prize Conditions:** Prize Winners will be required to execute an Affidavit of Eligibility, a Liability Release and a Publicity Release ("Affidavit/Release").
